NOTICE INVITING TENDER

Sealed Tender affixing court fee stamp worth Rs. 8.25 (Rupees eight and paise twenty five) only are invited from the reputed registered firm/suppliers for supply of the following pups for the Assam Police Dog Squad. The tender will be received upto 2.00 p.m on **25th July' 2016** and will be opened in the same day at 4.00 p.m. The tenderer may collect the tender papers/documents on payment of Rs. 500.00 (Rupees five hundred) only through uncrossed IPO/ Bank Draft from the office of the Addl. Director General of Police, CID, Assam, Ulubari, Guwahati w.e.f. **5th July/2016 upto 20th July ,2016** during office hours. Tender may also downloaded from the website "www.assampolice.gov.in. In that case the tenderer will have to deposit the tender fees along with the tender.

Terms and conditions:

1. The envelope containing the tender must be sealed and should be super scribed at the top as "**Tender for supply of Pups for the Assam Police Dog Squad**".
2. The tender must be registered under "**Live Stock Trade Association.**"
3. (a) Pups must be approximately 6 (six) months of age at the time of delivery.
(b) It is to be specified as to whether the firm will provide substitute, if any of the purchased Pup is found unsuitable for training in course of training, or dies during training.
4. Pups must be accompanied with,
 - (a) Registration certificate of K.C.I.
 - (b) Pedigree papers.
 - (c) Microchip No
5. Pups must de-wormed & vaccinated against.
6. The pups should be check-up through the Authorised Veterinary Doctor before the finalization of tender.

7. Each and every tender must be furnished Earnest money of Rs.10,000/- (Rupees ten thousand) only in favour of the Spl. Superintendent of Police, CID, Assam, Guwahati.
8. If the last date of tender receiving falls on any holiday/ band etc. the subsequent day will be treated as the last date of receiving tenders.
9. All tenders are required to furnish up-to date sale Tax/ VAT/ Income Tax clearance certificate and Trade License.
10. The rates must be written legibly both in figures and in subsequent words with clear indication of quantum (i.e. each pup etc.).
11. The cost of transportation of the pups from the selected supply firm to the training Centre at NTCD, Border Security Forces, Tekenpur, M.P may be mentioned in the tender if such transportation facilities is available.
12. The Rates quoted once cannot be altered / withdrawn after submission of tender. It will hold for 1 (one) year.
13. The rates should be quoted exclusive of VAT/AGST etc. Tax, if any should be shown separately.
14. The earnest money of unsuccessful tender be immediately refunded after finalization of the tenders.
15. The successful tenderer must shall have to deposit 5% of the total value of pups only as security money in the form of Bank Draft/Call deposit etc. pledged in favour of the undersigned.
16. Earnest money of the successful tenderer will be released as soon as the Security deposit is furnished.
 - (a) The successful tenderer will have to sign a contract agreement with “The Addl. Director General of Police, CID, Assam, Guwahati, or his authorised representative and abide by the terms and condition laid down therein as well as those of this tender notice. In the event of the contractor failing to perform his part of the contract to the satisfaction of the concern of his authorised representative disregards any terms and condition of either the contract agreement or the tender notice, he (the contractor) will be liable to any or all the following action.

- (i) Forfeit of security deposit in whole or in part.
 - (ii) Cancellation of the contract without any prior notice to the defaulting contractor.
 - (iii) Black listing of the defaulting contractors.
 - (iv) Failing to supply the “ **Live Stock Certificate**” of pups will be liable to cancel the tender.
 - (v) If any approve tender fail to supply the indented pups within the stipulated time period or after received of notice from the second party will be at liberty to cancel the contract agreement and may offer the supply orders to the next lowest tenders or the approved supplier.
 - (b) It shall be binding on part of the approved contractor’s to supply the approved rate at the particular supply point.
 - (c) Earnest money of the successful tenderer will be released as soon as the security Deposit is furnished.
17. The security deposit will be released to the contractor concerned after 6(six) months of completion of full supply of the pups.
18. (a) The selected firms/suppliers will have to execute a Deed of agreement with the undersigned and to furnish their PAN card issued by the income tax department.
- (b) The selected tenderer may convert their earnest Money to Security Deposit on application for due permission of suppliers.
19. The violation of the terms and conditions by the selected firms will lead to forfeiture of their earnest money / security money.
20. (a) The under signed is not bound to accept the lowest rates for pups and may reject any or all the Tenders without assigning any reason thereof.
- (b) All the legal proceeding arising out of any dispute between the parties shall be settled within the territorial jurisdiction of the Court in Assam.
