On behalf of Governor of Assam Sealed tenders in plain papers affixing Court fee stamp of Rs-8.25 (Rupees eight and Paisa twenty five) only are hereby invited from the intending contractors / suppliers for supply of Misc, articles, electrical goods and hardware goods for the year 2017-2018 will be received by undersigned upto 1200 hrs of 25.05.17. and will be opened on the same days at 1300 hrs in presence of intending tenders on their authorized representative.

The cover containing the tender should be superscripted as "Tender for supply of Misc, articles and must be dropped in tender box placed in the front of the office chamber of the undersigned.

The earlier tender notice issued vide Memo No- Bn12/Q/Misc/272-98 Dated- 21-06-2016 is hereby cancelled.

Terms of Condition.

All tenders must be submitted along with the following documents.

1. Firms Registration Certificate /AGST Registration Certificate (Attested copies).
2. Attested Copies up to date AGST Clearance Certificate.
3. Attested Copies of PAN Card /GIR No issued by I.T. Department.
4. VAT registration Certificate (Attested Copies).
5. Earnest money of Rs-3000/-(Rupees three thousand) only in the Bank draft duly pledged in favour of the undersigned. Must be closed along with the tender without which No, tender will be accepted. The Earnest money of the successful tender will be converted into security deposit and the earnest money of the successful tender will be realised accordingly.
6. Tender should quote rate all items size wise with name of Brand Company inclusive of all taxes. The rate quoted by the tenders for all items should be reasonable on the basis of rate prevailing in the open market at the time.
7. The articles to be supplied should be of best quality, otherwise the same will be rejected and the contractor will have to replace the at his own cost within 3(three) days.
8. The undersigned is not bound to accept the lowest rates and reserves the right to reject any all the tenders without assigning any reason thereof.
9. Tender will have to supply the articles within 3 (three) days from the date of receipt of the format order.
10. The successful tender will have agreement for supply of articles thereof though out the year 2017-2018 per rates approved at this office within 2 (two) days at his own cost. The cost of stamp paper etc for the agreement shall have borne by the tendered.
11. The successful tenderer must have to position to supply the Misc articles to Battalion Hqr. And to take up the same immediately on receipt of supply order from this office otherwise the security money will be for cited in the favour of the Govt. of Assam.
