

TENDER NOTICE

Short sealed tender on plain papers affixing court fee stamp of Rs. 8.25 (Rupees eight and twenty five paisa) only invited from the PWD registered and other reputed contractors for construction of the following works and will be received by the undersigned of hid authorized agents upto 2:00 PM on and will be opened on the same day place during office hours in presence of the tenderers or their authorized agents / representatives.

The tenderer should quote rates and total amount for each item both in figures & in words and should be inclusive of all taxes and incidental charges.

- The tender must*be written in ink or duly typed; any correction in the tender should invariably be attested with signature of the tender.
- The undersigned reserves the right to accept or reject any tender without assigning any reason thereof.
- All tender must be accompanied by 2% earnest money over the estimated value in the form of NSC/KVP/ Call deposit pledged in favour of the undersigned.
- The successful tenderers must be in a position to complete the work within the stipulated time mentioned above.
- The earnest money of the unsuccessful tenderers shall be released immediately on finalization of the contract.
- The successful tenders will have to furnish security deposit of 5% of the estimated amount. The earnest money of the approved tenderer already pledged may be converted as security money.
- In the event of the selected tenderer failing to complete the work satisfactory within the stipulated period mentioned above the contract will be liable to cancelled and security money will be forfeited.
- Selected tenderer will have to sign formal agreement with the Supdt. of Police (communication), Assam immediately from the date of issue preliminary work order failing which the earnest money will be forfeited.
- The sealed cover must be superscribed with the name of the work properly.
- Tenders should be submitted in the Office tender box.
- Detail specification may be seen in the office of the undersigned Supdt. of Police (C), Assam, Ulubari, Guwahati-7 during working days in office hours.
- Tenderer shall have to quote their rates and Flats P.C. basis i.e. as per above below the estimated amount and rates should be inclusive of all taxes and incidental charges.
- If the last date of receiving tenders falls on any holiday or bandh etc. the subsequent day may be treated as the last date of receiving tenders.
- The bidders must also submit the following along with the quotation.
 - Attested copy of Firm Registration.
 - Attested copy of GST Registration certificate.
 - Attested copy of PAN card issued by the Income Tax Deptt.
 - Income Tax statement for the Assessment Year
 - Up-to-date TIN number.
 - Up-to-date Bank Account number & IFSC Code.
- In due point of time, the competent authority shall arrange for inspection of the completed works to ensure proper quality of works done by concerned contractor.
- Force Majeure**
Any relationship or business connection that may exist between the bidder(s) and any officials in the Police Department or the Govt. of Assam either directly or indirectly through members of their families shall have to be declared by the bidder (s) while submitting the tender and if this information is found to be suppressed, the contract entered into shall be liable to be cancelled forthwith without notice and compensation and any security that may have been deposited shall be liable to be forfeited and credited to the Govt. of Assam forthwith.
- The undersigned is not bound to accept the lowest rate and reserves the right to reject or accept any or all quotations either partially or fully without assigning any reason whatsoever. In the event of any dispute the decision of the Supdt. of Police (Communication), Assam will be final and binding upon the tenderers in all cases.
