The bidder shall upload the scanned copy of E.M.D./Bid Security @2% of the quoted value in the form of FDR of Bank/Irrevocable Bank Guarantee with **validity for at least 6 (six) months** drawn in favour of Director of Police (Commn), Assam from any nationalized/scheduled bank and payable at Guwahati.

The original Bank Draft for Tender fees and original FDR of Bank/Irrevocable Bank Guarantee for E.M.D./bid security and samples should be submitted to the Director of Police (Commn), Assam in sealed covers on or before the Last Date of Submission of Hardcopy of the tender. The cover should be super scribed with details of the Tender.

3. The OEM or their authorized distributors/dealers must mention the proper registered office and correspondence address, working Phone No. /Mobile No., Fax No. and e-mail address. No substitute or additional addresses will be accepted.
4. To participate in this Tender process through e-procurement portal, the bidder should have a valid Digital Signature Certificate (DSC) of Class- II (minimum) and have to register in the portal <https://assamtenders.gov.in> themselves.
